ABOUT THE DEPARTMENT

ABOUT THE NATIONAL SEMINAR

The title of the National Seminar is "**Impact of Covid-19 Pandemic on Indian Economy, Labour and Marginalised Community**". The Covid-19 pandemic and the ensuing lockdown restrictions caused unprecedented job losses. The quantity and quality of employment opportunities both deteriorated and are estimated to not have returned anywhere close to the pre-pandemic numbers yet. The countrywide lockdown to contain the spread of Covid-19 pushed the labour migrants towards a pathetic situation marked by homelessness, hunger and unforeseen human miseries. A recent survey among migrant workers conducted in the middle of April 202 revealed that 90% of them were not paid their wages in various states, 96% did not get rations from the government outlets, and 70% did not get cooked food during the lockdown 1.0 (Hindu 2020).

Across the world, 2 billion workers (61.2 per cent of the world's employed population) are in informal employment. They are more likely to face higher exposure to health and safety risks without appropriate protection, such as masks or hand disinfectants. Many also live in cramped housing, sometimes without running water. This not only exposes these workers to health risks, it also makes preventive measures for the wider population less effective.

Coronavirus fears have sent shock waves across global financial markets. Indian capital markets are envisaging a funds flow to Western capital markets, owing to rate cuts and fall in the stock markets the world over. As per the NSDL data, Foreign Portfolio Investors (FPIs) have withdrawn huge amounts from India—₹247.76 billion from equity markets and ₹140.50 billion from debt markets in a short span of 13 days, that is, from 1 to 13 of March 2020.

The deleterious effects of the pandemic and the strict measures of lockdown have brought immense misery and risks for those who continue to be at the margins and fringes of the Indian society, even during non-COVID-19 times. These marginalised sections include the transgender community, the disabled, street children, sex workers, and others. The imposition of lockdown has not only aggravated precarity in their everyday survival but has also created more odds and obstacles in their efforts to earn their living and lead a "normal" life.

With India's stricter national lockdown, it is the vulnerable population—Dalits, Adivasis, Muslims and women from these communities—who have borne the brunt of social, economic and health impacts of the virus as both essential but disposable workers. It is more than clear now that people already marginalised and stigmatised, are the worst hit by the pandemic lockdowns. The hit is marked on several axes —psychological, economic, political, and cultural.

During lockdown, the support system for Persons With Disabilities (PWD)s is considerably affected, which demands an active response from the government and society at large. A majority of PWDs in India do not use any assistive devices and thus are dependent on others for performing their daily tasks. Availing transportation is a significant issue at this time as access to medicines and basic needs, like going to the market or ration shops, are a concern for the PWDs who are staying alone.

This seminar is meticulously planned to give intensive exposure to a topic through presentations and discussions led by multiple experts can lead to higher productivity and fulfilment of professional and academic goals. The seminar discussions offer chances to debate issues related to Impact of Covid-19 Pandemic on Indian Economy, Socio – Economic impacts, Impact of COVID-19 on migrant labourers, temporary wage earners, unemployed workers and semi – skilled workers, Impact of Covid on unorganized, informal and private sectors, Start-Ups and Micro, Small and Medium Enterprises and NRI labourers, Economic slowdown, livelihoods and agricultural labourers problems due to pandemic, Health, psychosocial, and economic impacts of the COVID-19 pandemic on Marginalised people, Strategy for start-ups and entrepreneurism in post covid situations.
