**Guidelines**

1. SJC-JSC facilitates only Indian Patents.
2. SJC-JSC will not consider Ideas/Utility Patents for facilitation.
3. SJC facilitates Patent-filing primarily for the faculty of SJC. However, co- inventors from other institutions/industries/ government bodies will be considered and legitimately charged based on the incurring expenses.
4. Technology Transfer for granted patents will be done by SJC in consultation with Technology Transfer Expert (TTE) and the profit will be shared with the inventor(s) as mentioned in the SJC-IPR policy (80:20 - Inventors: SJC). It is mandatory that 80% of the profit is shared among the inventors amicably. SJC will not be responsible for any legal contention in this regard.
5. Students/scholars must be duly granted inventorship if the inventions are based on their Project/Dissertation/Thesis. Otherwise, an Undertaking from the concerned students/scholars must be submitted along with the application.
6. Prior to applying for the Patent, faculty members are asked to carry out the prior art search. In this regard, faculty members are encouraged to approach Dr. R. Jerald Vijay, Coordinator, Patent Facilitation Centre (PFC), of the IPR Cell.
7. Submit the filled-in application form to the Director of Joseph Start-up Centre (JSC). Patent abstract should be submitted only in a sealed envelope.
8. The Applicant will be invited for a presentation in front the expert committee where the sealed envelope will be opened.
9. If any invention gets published by any means before the granting of Patent, the expenditure on Patent Facilitation must be reimbursed to SJC-JSC by the inventor(s).
10. The applicant will be held responsible for any false information provided and its implications.
